- 1) Name : SRI RAM KRISHNA EDUCATION & RURAL DEVELOPMENT SOCIETY
- 2) Place : R/o: Bhankalga, Tq: Chittapur, Dist: Gulbarga
- 3) Year : 1<sup>st</sup> April to 31<sup>st</sup> March

**4) AIMS AND OBJECTS OF THE ASSOCIATION (SOCIETY) :-**

- 1) The Sangha will work for development of General Public by getting financial assistance from State Government/Central Government and from General Public.
- 2) To open and run Computer Training Institute, L.K.G., U.K.G., Arabic School, Montessori and Nursery Schools, Primary, Higher primary, High School, Colleges, Medical colleges, Engineering colleges, Typewriting institutions, Tailoring training centers etc., and Job oriented education in English and Kannada/Urdu medium and also in any Indian languages.
- 3) To open and run women's Hostels, Boys Hostels and Ashram for Old age persons, Disabled persons etc.,
- 4) To promote Service orientation. To promote Human Resources Development.
- 5) Participate, Provide and promote the rural development, Health Family welfare, Environmental and other National Programmes.
- 6) To promote poor students by providing scholarships to help to the poor people by raising donations from the donors and Government and any agencies.
- 7) To Conduct any other cultural activities and other types of activities which are helpful and for the development and welfare of the humanity, in general.
- 8) To undertake programmes and projects for advancing the economical, Social and cultural interests of the society at large and in particularly the weaker sections and community development.
- 9) To undertake projects of rural development by adopting one village any where in India.
- 10) To render medical help to the public by starting dispensaries, hospitals, health centers, Aids awareness camps, health camps and blood banks.
- 11) To establish and run hostels for students, working women, public libraries, reading rooms, research centers, to promote or patronize all activities of education character for the benefits and utility of the general public, especial to the under privileged classes of society.



- 12) To promote or propagate understanding the history, culture art, music, and literature of Bharat or assist in conduction research in these fields.
- 13) To carryout on rural development programme like organizing, credit camps, farmers meet, providing street lights, public wells, and bore wells and lying and repairing the roads to propagate and motivate saving habits in rural masses for their better economic well being and any other activities for welfare and betterment of the living conditions of the rural people.
- 14) To establish and maintain homes or hostels for orphans, disables and abandoned persons.
- 15) In order to promote Social, Education, Economical, Cultural upliftment of the members and society with the help of State Government and even National and International Agencies.
- 16) Rehabilitation of the weaker section/Minority people and physically handicapped and invalid. To conduct programmes on women and childcare.
- 17) To establish and maintain libraries and community halls to promote social integration among the public.
- 18) To establish and organize in general social, educational, economical and cultural development of the people of the Karnataka.
- 19) The Committee is Non Government organization, implements state and Central Government schemes.
- 20) Any income derived from the society is utilized for the welfare of the Society and not distributed among the members.
- 21) Registration authority given to the **President** of the Sangha.

~ :: RULES AND REGULATIONS :: ~

- 1) Name : SRI RAM KRISHNA EDUCATION & RURAL DEVELOPMENT SOCIETY
- 2) Place : R/o: Bhankalga, Tq: Chittapur, Dist: Gulbarga
- 3) Year : 1<sup>st</sup> April to 31<sup>st</sup> March

4) MEMBERSHIP :

I) Any member must be the age of above 18 years of the either sex in the area of operation.

II) He/she should have accept the objects of the Association as mentioned in the Memorandum and should have agreed the rules and regulations.

III) Category of Membership as per the rate of donation:

a) Life Members : Who contributed the donation of Rs.1001-00 or more.

b) Ordinary Members : Who contributed the donation of Rs.251-00 or more. Ordinary members shall not added to the Governing Body.

IV) Any person shall become a member of the Association (Sangha) by an application duly recommended by a member of the existing Governing Body to the Secretary of the Society (Sangha)

V) The governing Body may or may not accept the membership of the applicant through a resolution and the application may be rejected on the following reasons.

- a) If the applicants is out of the area of operation.
- b) If the applicant is inactive part of the similar proceedings other than the political.
- c) If the applicant is insolvent by Judiciary and of unsound mind.
- d) If the applicant is inactive part of the similar institution having the same activities.

If the membership is accepted by the Governing Body the applicant shall contribute the donation as prescribed above within 15 days from the date of acceptance.


VI) Members once contributed the donation is not refundable under any circumstances and also not transferable in the same of any person.

VII) CESSION OF MEMBERSHIP:

- a) The membership fee shall be payable monthly and in case the fees is due in arrears for a period of more three months, the committee shall be empowered to change the membership with notice.

b) Any member intending to resign shall send a written intimation of the fact to the society.

c) Death.

d) Acting against the interest of the Society (Sangha)

VIII) Re-Enrolment:- Shall be made only on payment of arrears plus admission fees, if any and apology application is necessary.

5) GENERAL BODY :-

- i) The General Body meeting of the Association shall consist of all the members who have contributed the donation.
- ii) Meetings:- The First General Body Meeting shall be held within 18 months from the date of Registration and the subsequent General Body will be held within three months after the closure of the official year.
- iii) Notice:- A Notice of 15 clear days shall be given by the Secretary for initiating all the members with the agenda as approved by the Governing body.
- iv) Quorum :- 1/3 (One Third) member of the Society (Sangh) shall form the quorum for the General Body and no quorum is required for the adjourned General Body Meeting.
- v) Decision:- All the matters decided either unanimously or by the majority of votes shall be valid, in case of the equality of votes the president or the person who presided over the General Body shall have a casting vote.
- vi) Presiding Over The General Body :- The President or the other leading person as determined by the Governing Body shall preside over the General Body Meeting.

6) SPECIAL GENERAL BODY:-

The President of the Society either at his own may invite or in requisition signed by at least 1/3 of the total members of the Society may call the Special General Body Meeting with a notice of 10 clear days to transact the specific business.

7) GOVERNING BODY (BOARD OF MANAGEMENT) :-

- a) 1. The Affairs of the Society shall be vested in the Governing Body which consists of 07 or 09 members by the General Body.
2. The Governing Body elected by the First General Body shall hold office for a period of three years from the date of registration as per the Memorandum.
3. The member of the Governing Body shall officiate until they are replaced by the successor.
4. The members elected to the Governing Body shall in their first meeting elect among themselves, One President, One Vice President, One Secretary, One Joint Secretary, One Treasurer. The President and Secretary shall not be in any Govt. or Political Service.






- b) Meeting:- The Governing Body shall meet at least once in a month, if necessary in the middle.
- c) Notice :- Seven clear Days notice for the ordinary meeting and special meeting and three days for the emergency meeting shall be given.
- d) Quorum:- Five members shall form the quorum at an ordinary and special meeting and the quorum is however required for the adjourned meeting on the same object.
- e) Decision :- All the matters decided either unanimously or by majority of Votes shall be of valid, in case of the equality of votes the president or the person who preside over the meeting shall have casting vote. The Secretary shall record all proceedings at the time of meeting.
- f) Preside Over The Meeting :- The President shall over all the meetings of the Governing Body and the Sub-Committee in case if he is absent the members may elect one among themselves other than the Secretary to preside over the meeting on the date.

### 8) POWERS & FUNCTION OF THE GOVERNING BODY :-

The Governing Body shall be in sole and exclusive charge of the affairs of the association (Society) particularly on general exercise the following powers and functions:

- a) To lay down policies, in conformity with the norms and objects of the society.
- b) To approve the membership and to appoint a Sub-Committee to attend the specific function.
- c) Shall have powers to appoint the staff both the ministerial and technical required for running the administration and activities and to fix up the responsibility and employment and to assess the duties and security, to suspend the returned the staff members etc.,
- d) To raise up the financial resources from different agencies to fulfill the objects and activities.
- e) To carryout all programmes and activities of the association in the jurisdiction.
- f) To acquired, hold lease out, mortgage gift or sale of the assets in concurrence utilization and repayment of the over the loan and interest to the financial agencies.
- g) To arrange for the safe custody of the funds and assets and determine the mode of operation utilization and repayment of the over due loan and interest to the financial agencies.
- h) To fix up the honorarium and TA and DA to the office bearers and the staff members and to solve any dispute in the management and workers in consultation with the Financing agencies and also the maintain upto date accounts and records by the Secretary and to watch for the proper implementation of the activities and the business.





- i) The Governing Body shall have power to frame the subsidiary rules to the General working of the Society unsolved problems and be referred to the general body.
- j) The Governing body shall power to check the Cash and Stock at any time or periodically.
- k) Financial resources for the objects and the activities of the Society shall be raised through donation, State and Central Government, Co-operative / Scheduled Banks and Nationalized Bank etc.,

9) POWERS & FUNCTION OF THE PRESIDENT :-

- a) The President shall preside at all meetings of the Society when present.
- b) The President shall have discretionary powers in all matters not specifically provided for in these rules, or the bye-laws if any, framed by the Managing Committee.
- c) The President shall have power to get matters decided by the Managing Committee through circulation whenever deemed expedite where there is a no sufficient time to convene a meeting of Managing Body.
- d) To appoint and remove any staff of the society as required for the efficient management of the affairs and also to regulate the conditions of the Service.
- e) The duties of the President shall be honorary and shall not entitle for any benefit.
- f) The President may delegate his powers to Vice-President.

10) POWERS AND DUTIES OF THE SECRETARY :-

- a) To Secretary shall be responsible for maintaining the record of the Society.
- b) To run the society properly.
- c) To obtain buildings on monthly rents (For School)
- d) To call for meetings of the Managing Body as well as General Body.
- e) Record the proceedings in minute book.
- f) To act correspondent of the Association.
- g) To assign all documents in favor of the Society and to act as their sole attorney and to do such things as are necessary for the well being of the society.
- h) To give such details as are called for by the Registrar.

11) THE FUNCTIONS & DUTIES OF THE TREASURER :-

The Treasurer and President shall have the authority to operate the Society accounts with Bank in a joint Signature of President and Treasurer or President and Secretary or by Secretary Individually. Treasurer shall maintain all the accounts of the society upto date.

12) BANK TRANSACTION :-

President and Secretary shall have the authority to open and operate the Society accounts with their joint signature or as decided by majority of governing body members from time to time.

13) AUDIT :-

The Accounts of the Society shall be audited by a Recognized Chartered Accountant in every year and the audit Report should be approved by the General Body. All the Audit rectification shall be brought to the notice of the members by calling the General Body or to the Chartered Accountant within 15 days after attend the audit rectification.

14) ANNUAL RETURNS:-

The annual returns to these rules shall be filed in every year with the Registrar of Societies accordance with the Section 6 No. 13 of K.S.R. Act 1960.

15) AMENDMENTS:-

No Amendment to these rules shall be allowed except the permission of the General Body attend by 75% of the member on the rool and with the approval of the Registrar. A copy of these rules shall as maintained in the office of the Society with the Certificate of the Registrar.

16) AMALGAMATION:-

Any amalgamation and dissolution shall be made in accordance with Section No.22 and 21 of K.S.R. Act.1960 and also with the concurrence the concerned authorities.

17) WORKING HOURS:

The working hours of the office of the society shall be 10-00 am., to 1:30 pm., and 2:30 pm., to 5:30 pm.

18) OFFICIAL YEAR :

The Official year shall be April to March in the year.

19) OTHERS:


Per matters and things which has not been specifically provided for here in above, provision of K.S.R. Act 1960 and framed there under shall apply.

20) ELECTION :-

Election can be conducted by raising hand or by secret ballot paper.

21) It hereby agreed upon by all members of ( Name of Society or association /Society that no child labour of any from specifically, domestic child labour, will be employed in the premises of the society/Association complexes and in apartments have and residences either owned or rented.





- 22) INVESTMENT CLAUSE: The funds of the society shall be invested in the modes specified under the provisions of the Sec. 13(1) (d) read with Sec. 11(5) of the I.T. Act. 1961 as amended from time to time.
- 23) AMENDMENT CLAUSE: No amendment to the society bye laws shall be made which may prove to be repugnant to the provisions of Sec. 2(15), 11, 12 and 13 & 80 G of the I.T. Act, 1961 as amended from time to time. Further no amendments shall be carried out without the prior approval of the Commissioner Income Tax.
- 24) DISSOLUTION CLAUSE: In the event of dissolution or winding up or amalgamate of the society, the assets remaining as on the date of dissolution/winding up/ amalgamate shall under no circumstances be distributed among the members but same shall be transferred to another Institutions / Society / Trust whose objects are similar to those trust / society and which enjoys recognition u/s 80 G of the I.T. Act 1961 as amended from time to time.
- 25) The society formed shall be irrevocable
- 26) The benefits of the society shall be to all irrespective of caste creed, Or religion.
- 27) The funds and the income of the society shall be utilized for achievement of its objects and no portion of shall be utilized for payment to members by way of profit, interest, dividends.










